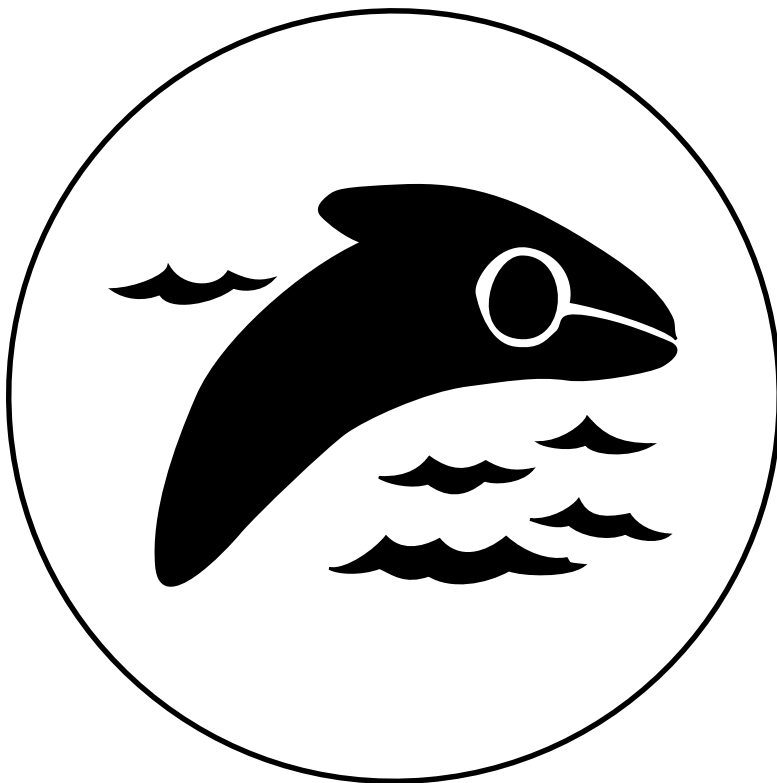

PCAS is an avocational group formed to study and to preserve the anthropological and archaeological history of the original inhabitants of Orange County, California, and adjacent areas.

The Publications Committee invites the submittal of original contributions dealing with the history and prehistory of the area. Although PCAS is especially interested in reports which shed further light on the early inhabitants of Orange County, it is always interested in reports on the wider Pacific Coast region.

Subscription to the *Pacific Coast Archaeological Society Quarterly* costs \$35 for calendar year 2007. The PCAS also publishes a monthly newsletter, which costs \$15 for calendar year 2007. There is an additional postage charge for foreign subscriptions: \$9 for the *Pacific Coast Archaeological Society Quarterly* and \$4 for the *PCAS Newsletter*. Back issues of the *Pacific Coast Archaeological Society Quarterly* are available for \$12 per single issue (including postage and handling for domestic address).
