About the Authors

Mariam Dahdul received a B.A. in Geography from California State University, Fullerton in 1993 and an M.A. in Anthropology from the same institution in 2000. Dahdul has worked as a project archaeologist in the cultural resources management field since 2000. Her main area of interest focuses on Coachella Valley prehistory.

Matthew R. Des Lauriers received his M.A. from University of California Riverside and is currently completing his Ph.D. studies in Anthropology at UC Riverside. Most recently, he has conducted archaeological and anthropological research in Baja California Sur. His research interests include settlement systems, coastal adaptation, and faunal evidence among hunter-gatherers.

Nancy Anastasia Desautels is president and research director of the cultural resource management firm, Scientific Resource Surveys, Inc., Temecula, California. She has extensive archaeological experience in the United States and Europe and has been a member of the Franchthi Cave research team in southern Greece since 1973. In southern California, Dr. Desautels has a wide range of interests in both historic and prehistoric archaeology.

Jelmer W. Eerkens received his Ph.D. from University of California Santa Barbara in 2001, and is currently Assistant Professor of Anthropology at the University of California, Davis. His research interests include hunter-gatherer adaptations to different environmental and social conditions, the origins and transmission of new technologies, resource intensification and the development of incipient agricultural systems, and land tenure systems among hunter-gatherers. He works primarily in California and the Great Basin, though has also worked in Northwestern Europe and Peru, and is interested in the application of archaeometric techniques to anthropological questions about the past.

Roberta Greenwood's long list of projects and publications spans the entire range from 9,000 years at Diablo Canyon and the first prehistoric chronology for the Central Coast to the latest historical studies about missions and Chinese sites. Educated at Wellesley College, Boston University, and UCLA, she was one of the original members of SOPA, now RPA, and has held offices in various national and state professional organizations. As president of Greenwood and Associates, her concerns for preservation are illustrated by the on-going restoration of a Chinese temple in Cambria, and the effort reported here that concluded her 18 years as MTA archaeologist during construction of the MetroRail Red Line.

Susan Hector received a Ph.D. in anthropology from the University of California, Los Angeles, in 1984. Her research interests include the history and archaeology of California, with an emphasis on the late prehistoric and contact periods. She was the project manager for several adobe restoration projects, and has written about historic building methods. Dr. Hector is the Principal Manager for Susan Hector Consulting.

A. J. Timothy Jull received his Ph.D. in Geochemistry from the University of Bristol in 1976. He is presently a Research Scientist at the University of Arizona Accelerator and Spectrometry Facility. Among his many interests are geophysical applications of C-14 and other isotopes and C-14 and other radionuclide measurements by accelerator.

Henry C. Koerper has just finished his thirtieth year of teaching at Cypress Community College, prior to which he taught at Chapman College, Stanislaus State College (part-time), Voi Harambee High School, Kenya, and U. C. Davis, where he was first a reader and grader, then a teaching assistant, and finally an Associate in Anthropology. He received his Ph.D. from the University of California, Riverside, in 1981. He has published in a number of archaeological and anthropology journals including *Journal of California Great Basin and Anthropology* and *Pacific Coast Archaeological Society Quarterly*.

Armand J. Labbé, Director of Research and Collections and Chief Curator at the Bowers Museum of Cultural Art in Santa Ana, California, has authored numerous books and scholarly articles pertaining to the art and prehistory of ancient civilizations, particularly those of the New World and ancient Thailand. He has curated numerous major exhibits of prehistoric art. In addition to his work at the Bowers Museum, Professor Labbé has taught art and prehistory at colleges and universities such as the University of California, Irvine, and California State University, Fullerton. Labbé received his undergraduate training at Indiana University, Bloomington, and the University of Massachusetts, Amherst. His graduate work in anthropology was undertaken at the University of Massachusetts, Amherst, and California State University, Fullerton.

Bruce Love earned his Ph.D. in Anthropology from UCLA in 1986. From 1987 to 1990 he was owner and principal investigator for Pyramid Archaeology specializing in archaeology of the Antelope Valley. From 1990 to 1993, Love was director of the Archaeological Research Unit at University of California Riverside, after which he once again formed his own company focusing on inland desert and mountain regions of Southern California. Love was owner and principal for CRM TECH, based in Riverside, from 1993 to 2003. In 2003 he retired from California CRM and is now concentrating his research efforts on Mesoamerican cultures, in particular the Ancient Maya and their hieroglyphic writing.

Jeff Rosenthal received his Master's degree from Sonoma State University in Cultural Resources Management. For the past seven years, Mr. Rosenthal has been an Archaeologist with Far Western Anthropological Research Group, Inc., in Davis, California. His research interests include hunter-gatherer economies and settlement systems, chronometrics, and geoarchaeology.

Mark Q. Sutton received a Ph.D. in Anthropology from the University of California, Riverside. He is an Associate Professor in the Department of Anthropology at California State University, Bakersfield. Dr. Sutton's research interests include the California deserts, the Great Basin, and the southern Sierra Nevada. He has published in a number of archaeological and anthropological journals including the *Journal of California and Great Basin Anthropology*, the *Masterkey*, *Kern County Archaeological Society Journal*, and University of California Institute of Archaeology, Los Angeles Monograph series.
